***Ref: Approval of the project to be financed from the reserve list of the first call for strategic project proposals of the Romania – Serbia Interreg IPA Cross-Border Cooperation Programme***

**Dear JMC members,**

Following the second meeting of the JMC held in Timisoara on 5 October 2016, the Decision no. 43 of the JMC approving the projects to be financed under the first call for strategic project proposals and the project to be placed on the reserve list has been issued.

According to the above mentioned Decision, the list of projects to be financed is composed by projects SP 520 (*The repairing of the navigation infrastructure on Bega Canal*) and SP 515 (*Planning and design for a new and high velocity road between Timișoara and Pančevo*) and the project to be placed on the reserve list is project SP 514.

The Decision specifies that the reserve list shall be valid until the decision of the second call for proposals is taken by the JMC.

Considering the above mentioned decision, the JS begun the pre-contracting process informing the Lead Beneficiaries on the approval of their project proposals and proposing a pre-contracting on-site visits calendar.

Following the JS proposal, both Lead Beneficiaries requested to postpone the pre-contracting on site visits.

During the third JMC meeting held in Kikinda on 13.12.2016, the JMC concluded that the JS will inform the Lead Beneficiaries of the 2 strategic project proposals that the pre-contracting on site visits must be performed after 16<sup>th</sup> of January, but no later than the end of January for project proposals SP 515 and 15 of February for project proposal SP 520.

According to the conclusions of the JMC meeting from 13.12.2016, the JS proposed to the Lead Beneficiaries a new schedule for the pre-contracting on-site visits.

Following the JS notifications only the Lead Beneficiary for project proposal SP 520 answered and the pre-contracting on-site visits have been performed.

For project proposal SP 515 the JS did not received an agreement or proposal for postponing the pre-contracting on-site visit until now.

Considering the lack of response, the JS proposed to the MA the finance rejection on 30.01.2017.

Therefore, after the MA and NA's agreement on the JS proposal for finance rejection, according to the Evaluation Selection and Contracting Procedure, the JMC is formally notified on the rejection of the following strategic project proposal:

**Project SP 515**, "*Planning and design for a new and high velocity road between Timișoara and Pančevo*",

**Lead beneficiary:** *Ministry of Transport (Romania)*,

**Partner 2 :** *Public Enterprise Roads of Serbia (Republic of Serbia)*.

On this matter please find attached the JS finance rejection proposal for the strategic project proposal no. SP 515.

Considering the rejection of the strategic project proposal SP 515, according to the JMC decision no. 43, we propose, for your approval the contracting of the strategic project proposal placed on the reserve list, namely:

**Project proposal SP 514** *“Romania-Serbia joint initiative against cancer in cross-border region: improved diagnosis and treatment of malignant tumors”*

**Lead beneficiary:** *General Hospital Pozarevac*

**Partner 2:** *Ministry of Health of the Republic of Serbia*

**Partner 3:** *Emergency Clinical County Hospital „Pius Branzeu” Timisoara*

**Partner 4:** *County Emergency Hospital Resita.*
